GET YOUR 2010 INSPECTION STICKER FROM ODNR!

**Ohio Department of Natural Resources
Division of Watercraft**

OHIO REQUIRED EQUIPMENT

1. Title
2. Registration & Numbers (Current licence from the State and OH numbers on the watercraft)
3. Personal Flotation Devices - Wearable device for each person on board
4. Fire Extinguisher
5. Visual Distress Signals - for both day and night use. - distress flag
6. Sound Signaling Devices - Power whistle or horn and a bell.
7. Anchor and Line
8. Lights - Running lights and anchor light
9. Ventilation - Engine and fuel tank compartments
10. Engine Cutoff Switch - Jetskis

We have been informed that these requirement will be checked by the Ohio Department of Watercraft this year. So before you put your watercraft in the lake. Please make sure all the equipment is onboard.

ORC 1547.06 Child Operators Prohibited: Except as provided, no person under 16 years of age shall operate a personal watercraft (PWC). Individuals not less than 12, nor more than 15 years of age may operate a PWC if a supervising person 18 years of age or older is also on board. etc.
