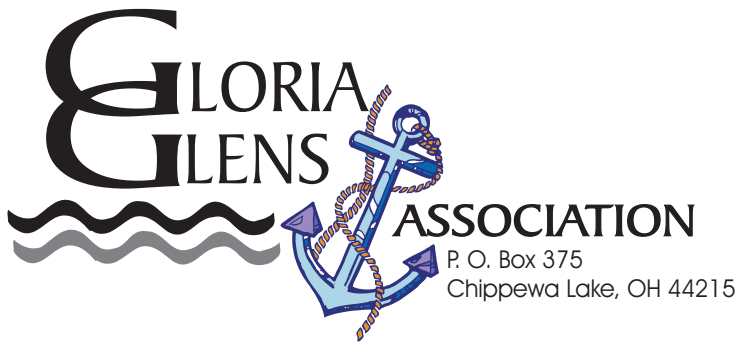

BOAT RAMP KEY RULES AND REGULATIONS

1. To be eligible to put a watercraft on the lake you **MUST FIRST BE A CURRENT MEMBER OF THE GLORIA GLENS ASSOCIATION.**
2. Owners of a residence (**a home not just a parcel of property**) in the Village of Gloria Glens Park is eligible for a boat ramp key and watercraft sticker.
3. **RENTERS ARE NOT ELIGIBLE FOR THESE PRIVILEGES.**
4. In order to be eligible the watercraft must be **OWNED** (titled) by the owner. Proof of ownership for the watercraft and also proof of ownership of the property must be presented to obtain a key.
5. The key will remain the property of the **GLORIA GLENS ASSOCIATION** and must be returned to the Association when a residence is sold or transferred or no longer a member in good standing and keys are subject to repossession by the Association in the event of a violation of any of these rules. Only one key will be issued per resident.
6. Each owner who will be entitled to a key will be issued one weatherized sticker for each watercraft the persons intends to use on the ramp. In order to be eligible for a sticker, each watercraft must be owned by the property owner, evidence by a title or registration in the person's name is required.
7. Only persons with a properly issued key will be permitted to use the gate and boat ramp, and they may only use it for watercraft which have been properly registered in that person's name which have the appropriate sticker affixed to the watercraft.
8. Watercraft stickers shall be displayed on the watercraft(s) at all times. Watercraft stickers will be placed on the front right hand side above the water line, below the watercraft cover line. The watercraft sticker shall be in clear view without obstruction at all times.
9. Authorized boat ramp users shall not lend their key or permit use of their key by any person who is not entitled to use the boat ramp or for a watercraft not properly registered to him or her. Leave the gate open or unlocked is also not acceptable. **(Failure to abide by this rule is justification for repossession of the members key)**
10. Close and lock the boat ramp gate immediately after passing through the gate. Your key cannot be taken out of the lock until the lock is closed or locked. **DO NOT LEAVE THE GATE OPEN.**
11. Cars with boat trailers **MAY NOT BE PARKED IN THE BEACH PARKING AREA.** They must be taken back to their residence.
12. **LENDING YOUR KEY TO OTHER WATERCRAFT OWNERS OR NON-RESIDENTS IS PROHIBITED AND IS IN VIOLATION OF THE BOAT RAMP USAGE REGULATIONS. (This action is subject to repossession of the key)**
13. Duplication of boat ramp gate key is prohibited and is in violation of the boat ramp usage regulations. **(The keys are unduplicable, marked with the Gloria Glens name and also assigned a number)**
14. The **ASSOCIATION** shall maintain a ledger listing each key and sticker issued, which will include the key number, the property owner name, address, telephone number, date of issuance of the key, sticker and identification of each watercraft for which a sticker has been issued.

I the undersigned do state that I am a property residence owner and watercraft owner as noted above. I have read the **GLORIA GLENS BOAT RAMP USAGE REGULATIONS** concerning the use of the boat ramp and further understand that violation of these rules and regulations concerning the key issued to me is the property of **GLORIA GLENS ASSOCIATION** and must be returned to the **ASSOCIATION** when my property is sold or transferred. **DO NOT SIGN UNTIL YOU RECEIVE YOUR KEY AND STICKER.**
